| <b>Would you support legislation to change the age of a person who can purchase a firearm in Delaware from 18 to 21, similar to HB 330 (during the 149th General Assembly)?</b>  |  |   |

| <b>Would you support "unsafe storage of a firearm" legislation, which would revise the crime of 'unlawfully permitting a child access to a firearm' from a class A misdemeanor to a class B misdemeanor, similar to what was laid out in HB 366 (during the 149th General Assembly)?</b> |  |   |

| <b>Would you support efforts to prohibit the manufacture, sale, purchase, transfer, or delivery of large-capacity magazines, as they were defined in HB 375 (during the 149th General Assembly)?</b>   |  |   |
| <b>Yes</b>   | <b>I would like to see the State have a "buyback program" I proposed such a plan last year and was told there was not enough money---poor excuse!</b>  |   |
